TRAP & SKEET FIELD RULES

FOR YOUR SAFETY AND THE SAFETY OF OTHERS, PLEASE RESPECT THE FOLLOWING RULES WHEN USING THE TRAP & SKEET FIELDS:

- **ALWAYS** MONITOR THE SAFETY AND GUN HANDLING OF ALL PERSONS USING THESE FACILITIES. IMMEDIATELY REPORT ANY PROBLEMS TO THE RANGE SAFETY OFFICER, EVENT DIRECTOR/JUDGE OR TO A CLUB OFFICER - SAFETY FIRST!
- **ALWAYS** HAVE AN ADULT 18 YEARS OR OLDER PRESENT ANYTIME FIREARMS ARE IN USE.
- **ALWAYS** WEAR EAR AND EYE PROTECTION WHILE ON THE FIELDS DURING ANY SHOOTING ACTIVITY - NO EXCEPTIONS!
- **ALWAYS** BE SURE YOUR FIREARMS ARE UNLOADED WITH ACTIONS OPEN WHEN NOT ON THE FIRING LINE. EXCEPTION: HINGED-ACTION GUNS MAY HAVE ACTIONS CLOSED WHILE STORED IN THE GUN RACKS.
- MEMBERS MUST BE CURRENT WITH THEIR DUES TO USE THE SKEET/TRAP FIELDS. MEMBERS ARE EXPECTED TO REGISTER ON THE LOG IN THE SHOOTER'S SHACK AND PAY FOR EACH ROUND THEY SHOOT.
- **OPENING THE SKEET/TRAP FIELDS:** "QUALIFIED" MEMBERS WITH A GENERAL KNOWLEDGE OF THE SAFE OPERATION OF THE EQUIPMENT MAY OPEN AND OPERATE THE FIELDS. "QUALIFICATION TRAINING" MAY BE ARRANGED THROUGH ANY OFFICER OF THE CLUB.
- **UNDER NO CIRCUMSTANCES IS ANYONE ALLOWED TO MAKE ANY MECHANICAL ADJUSTMENTS OR REPAIRS TO THE EQUIPMENT!**
REPORT ANY PROBLEMS TO THE PROPER PERSONNEL LISTED IN THE SHOOTER'S SHACK.
- **CLOSING THE SKEET/TRAP FIELDS:** QUALIFIED MEMBERS MUST SEE THAT ALL EQUIPMENT IS PROPERLY STORED. ALL MACHINES MUST BE FULLY RELOADED, TURNED OFF AND RELEASED INTO A SAFE POSITION. ALL EMPTY TARGET BOXES MUST BE PUT INTO THE BURNING RECEPTACLES. THE MAIN POWER FOR THE FIELDS MUST BE SHUT OFF IN THE SHOOTER'S SHACK. ALL HOUSES MUST BE LOCKED AND SECURED.
- **ALWAYS** PICK UP YOUR EMPTY SHELL CASINGS AND BOXES AND DISPOSE OF THEM IN THE RECEPTACLES PROVIDED. EXCEPTION: DURING LEAGUE EVENTS, SHOOTERS SHOULD LEAVE ANY EMPTY SHELL CASINGS THAT DROP TO THE GROUND. EVENT STAFF WILL PICK THEM UP PERIODICALLY.
- THE RIFLE RANGE **MAY NOT** BE USED DURING ANY SCHEDULED SKEET/TRAP EVENTS. THE RIFLE RANGE **MAY NOT** BE USED ANY OTHER TIME THE TRAP FIELDS ARE IN USE. THE RIFLE RANGE **MAY** BE USED WHILE THE SKEET FIELDS ARE IN USE, BUT ONLY IF THOSE SHOOTING SKEET AGREE.

UNDER NO CIRCUMSTANCE WILL ANY OF THE FIELDS BE USED FOR SHOOTING WHILE MAINTENANCE IS BEING PERFORMED ON THE FACILITIES WITHOUT THE PERMISSION OF THE PERSONS PERFORMING THE MAINTENANCE! ANY VIOLATION OF THIS RULE WILL RESULT IN DISMISSAL FROM THE CLUB!

ANYONE FOUND SHOOTING IN AN UNSAFE OR DESTRUCTIVE MANNER WILL BE SUBJECT TO DISCIPLINARY ACTIONS, WHICH CAN INCLUDE DISMISSAL FROM THE CLUB AND CIVIL ARREST!

UNSPORTSMAN-LIKE CONDUCT WILL NOT BE TOLERATED AT OUR CLUB!
